ORDER

Based on the announcement made by the Hon'ble Chief Minister under TNLA rule 110 earlier, Government have issued Order in the reference first read above providing 75% grant of the total development cost upto a maximum of Rs.15 crores to the entrepreneurs prepared to shift their existing units outside the town areas and shall provide 50% of grant with maximum grant limited to Rs.10 crores to the entrepreneurs associations coming forward to set up new clusters in the outskirts of towns/ cities.

2. Among other things, the Hon'ble Minister (Rural Industries and Labour) has announced the following announcement:-

"further, the private entrepreneurs who are willing to form Industrial Estate with minimum extent of 100 acres by themselves or joint venture mode Tamil Nadu Small Industries Development Corporation Limited will join with them and for form Industrial Estates. The benefits of grant ordered vide G.O. Ms. No. 44, Micro, Small and Medium Enterprises Department, dated 04.09.2013 will be extended to encourage such ventures.

3. In the letter third read above, the Principal Secretary / Managing Director, TANSIDCO has sent proposal along with a draft guidelines to Government and requested to issue guidelines for establishment of Integrated MSME Growth Park.

4. The Government after careful examination of the above proposal have decided to issue the Guidelines for establishment of Integrated MSME Growth Park (IMGP) Scheme to be implemented by SIDCO. The purpose of this Scheme is mainly to provide support for Industrial Infrastructure to the Association of MSME Units. They will be eligible for 100% assistance under this scheme. Any other legal entity, including a firm or a Company / Society / Trust that forms joint venture with SIDCO would be eligible for 90% assistance under the scheme subject to the following conditions:

- i. The Joint Venture companies, to be eligible for assistance under this scheme, should have minimum 11 % stake of SIDCO.
- ii. There should be a representative of SIDCO in the Board of Directors.
- iii. SIDCO representative should have a decisive say in matters related to pricing of land. Such matters will not be decided in their absence. If there is a difference in opinion with the SIDCO representative, then the matter will be referred to SIDCO for final decision.
- iv. The Joint Venture agreement should have an effective exit clause that will enable SIDCO to exit after 100% land allotment to private companies in the estate is completed. The exit policy should also ensure constitution of society or association to ensure the future maintenance of the estate .

5. The Guidelines for establishment of Integrated MSME Growth Park Scheme are annexed to this order.

6. This order issues with the concurrence of Finance Department vide its U.O. No.46312/Ind/2016 dated 06.09.2016.
