ORDER:

At present the Industrial Estates and Developed Plot Estates Programme are implemented by the Director of Industries Small Industries Development Corporation and State Industries Promotion Corporation. The Government have been examining for some time the question of co-ordinating the functions of these agencies to avoid overlapping and duplication of their functions. At the same time, the Government are also considering the ways to utilise institutional finance in a much large measure for implementing these two programmes. The Government of India have also been emphasising that the Industrial Estates Programme and Developed Plot estates programme should henceforth be implemented, by the State Development and Promotional Corporations set up for this purpose. In this context the Government have examined the question relating to the agency for implementing future industrial Estates and Developed Plot Estates Programmes and pass the following orders:-

- (1) All future conventional Industrial Estates will henceforth be undertaken by the Small Industries Development Corporation.
- (2) Regarding functional Industrial Estates where a separate Corporation for the industry concerned exists or is set up in future like the Ceramics Corporation, or the proposed Electronics Corporation, that Corporation will undertake the construction of such Functional Industrial Estates. If no such Corporation exists now, they should be transferred to Small Industries Development Corporation.
- (3) In the Functional Industrial Estates common service facilities like laboratories etc., will be undertaken by the Corporation concerned. The Corporation will subsidise the services thus rendered and if on account of these the Corporation incurs any loss, it will be met by the Corporation.
- (4) All existing conventional Industrial estates will also be transferred to Small Industries Development Corporation for maintenance. The staff now in the Directorate looking after the Industrial Estates including maintenance and construction staff will also be transferred

to the Corporation: The staff should be on deputation for one year only, during which period it should be asked to exercise an option between Government Service and Corporation Service, on the basis of orders, in force at the time of option.

- (5) The existing functional Industrial Estates will be transferred to the appropriate functional Corporations and to Small Industries Development Corporation, if such a Corporation does not exist.
- (6) All the existing Developed Plot Estates will be transferred to State Industries Promotion Corporation of Tamil Nadu.
- (7) The existing Industrial Estates will be transferred to the appropriate Corporation at the original cost.

2. The above orders will take effect from 1st June, '74.

3. The Director of Industries and Commerce is requested to take necessary urgent action to implement the above orders of the Government in consultation with the Small Industries Development Corporation and State Industries Promotion Corporation of Tamil Nadu. He is also requested to submit proposals for the transfer of staff and the assets and liabilities, consequent on the transfer of the functions relating to the Industrial Estates ordered above.
