ORDER:

In the Government Order first read above, Tamilnadu Small Industries Development Corporation Limited has been appointed as an agent of the Government, for the management of the Government conventional Industrial Estates and tenements in the Industrial Estates. The Chairman and Managing Director, Tamilnadu Small Industries Development Corporation Limited was requested to submit necessary proposals for stipulation of the terms and conditions of the agency the quantum of remuneration etc., in consultation with the Director of Industries and Commerce. In the Government order second read above, Tamilnadu Small Industries Development Corporation Limited has also been appointed as an agent of the Government for maintenance of the six Developed Plot Estates at Ambattur, Guindy, Thuvakudi, Keopalur, Mettur and Trivellore. The above six Developed Plot Estates have been transferred from State Industries Promotion Corporation of Tamilnadu to Tamilnadu Small Industries Development Corporation Limited for maintenance with effect from 1.8.76.

2. The Chairman and Managing Director, Tamilnadu Small Industries Development Corporation Limited in his letters read above has submitted proposals for the finalisation of agency terms and conditions on the following points:-

- i. Dealing with the Government property both purchasing and selling.
- ii. Incurring of an expenditure of capital nature for expansion of new construction.
- iii. Maintenance of Estates and Staff.
- iv. Agency commission
- v. Repayment of the net balance of rent collected and
- vi. Miscellaneous matters.

3. The Government have examined carefully the proposal of Tamilnadu Small Industries Development Corporation Limited and pass the following orders on each of the items mentioned in paragraph 2 above;

- i. Power of Attorney is granted to Tamilnadu Small Industries Development Corporation Limited to deal with the Government property such as allotment of sheds, tenements and godowns, cancellation of allotments, execution of ~~negotiation~~ assignment deed, demanding the unit holders to inspere the buildings, approval of additions and alterations in the units and carryingout of additional constructions, eviction of unauthorised occupants, collection of rental arrears from the unit holders under the provisions of the Revenue Recovery act, write off of the irrecoverable amount and in short carrying out of all other works which a owner of a building and land will normally do.
- ii. The powers relating to the following matters will, however, continue to vest with the Government,
 - a. to allot and sell sheds and lands above an extent of 1000 sq.ft
 - b. to sell the sheds on hire purchase basis,
 - c. to fix the rent for the sheds etc.,
- iii. Tamilnadu Small Industries Development Corporation Limited is permitted to incur expenditure towards the payment of enhanced compensation for the lands requisited, for the expenditure of a capital nature, for expansion of new plant, the approval of the Government should be obtained.

iv) The staff cost and the maintenance expenditure should not exceed the percentage worked out with reference to capital costs of the Industrial Estates and Developed Plot Estates as indicated below:-

Tamilnadu Small Industries Development Corporation Limited should therefore take action to review the staff strength accordingly.

v) Permission is granted to Tamilnadu Small Industries Development Corporation Limited to execute normal repair works, annual maintenance work and occasional repair works that may arise due to natural calamities, in this Industrial Estates and Developed Plots subject to a maximum limit of Rs. 10 lakhs per annum. Out of the above, no more than 25% will be capital expenditure without which the expenditure will be covered by the 10% annual general annual maintenance and special fund e.g. work of repairing calamities. Within 15 days of the total amount of the ratification of the Government, say by the Government of Tamilnadu, Small Industries Development Corporation Limited will make payment to the Corporation after the special repair works and the calamities are over.

vi) No agency commission will be paid to Tamilnadu Small Industries Development Corporation Limited for the management of the Industrial Estates and Developed Plot Estates.

vii) The net balance of rent of Rs. 131 lakhs collected by Tamilnadu Small Industries Development Corporation Limited as on 31.3.1977 should be repaid to Government in 8 quarterly instalments commencing from 31-12-77. Interest at 11% per annum will be charged for the period for which the amount had been held by Tamilnadu Small Industries Development Corporation Limited from the date of collection to the date of repayment and penal interest at 13% will be charged for any delayed payment.

viii) Permission is granted to Tantipadi Small Industries Development Corporation Limited to write off the losses upto a limit of Rs. 5000/- and obtain the approval of the Government therefore once in a year.
