ORDER:

According to Government Business Rules, the Small Industries Department in State Secretariat deals with the all subjects matters relating to Small Scale Industries, the administration of Industries and Commerce Department including District Industries Centres, all matters relating to the public sector undertakings viz Tamil Nadu Small Industries Corporation Limited, Tamil Nadu Small Industries Development Corporation Limited and the Entrepreneurs Development Institute. The union and concurrent subjects relating to industrial policy matters pertaining to small scale industries, kea matches, sago and coir production in this State are also dealt with in this Department

Consequent on the enactment of Micro, small and Medium Enterprises Development Act, 2006 Government of India have merged the Ministry of Small Scale Industries and Ministry of Agro & Rural Industries and formed a new Ministry, called as Ministry of Micro, Small and Med Jum Enterprises (MSME). Therefore, a need has arisen to change the nomenciature of the present Small Industries Department as "Micro, Small and Medium Enterprises", with a view to formulate comprehensive policies and schemes towards the industrial development of these sectors in the State. It will also enable the public to Identify the Department which Is dealing, Micro, Small and Medium Enterprises in the State.
