ABSTRACT

INDUSTRIES - Developed Plot Estates - Tamil Nadu Small Industries Development Corporation Limited to act as an agent of the Government orders - issued.

ORDERS

In the G.O first read above, orders were issued transferring all the conventional Industrial Estates which were hitherto under the control of the Director of Industries and Commerce to the Tamil Nadu Small Industries Development Corporation with effect from 1.6.74. In the G.O orders were also issued transferring the existing Developed Plot Estates to be State Industries Promotion Corporation of TamilNadu with effect from 1.6.74. In the G.O Second read above the Government appointed the Small Industries Development Corporation as an agent of the Government for the Management of the conventional industrial Estates and the tenements in the Indl. Estate on remuneration basis and ordered that the ownership of these Estates will continue to vest with Government.

2. The Managing Director, State Industries Promotion Corporation of Tamil Nadu has submitted proposal for transferring the Developed plot Estates to the Small Industries Development Corporation as most of the allottees are small scale industrialists and that the nature of work to be attended to pertains only to small Scale Industries Small Industries Development Corporation has also agreed to this proposal. The Government accept the proposals and pass the following orders:

ii) The six developed plot Estates of Ambattur, Guindy, Thuvakudi (Tiruchir Dist) Kappalur (Madurai) Mettur and Trivellore be transferred to the Small Industries Development Corporation for maintenance on an agent of the Government arrangement basis. The date of transfer of these estates to Small Industries Development Corporation will be from the date on which they were handed over by State Industries Promotion Corporation of Tamil Nadu known to the Government. This date should be intimated to Government as soon as the transfer is effected. The terms and conditions of the agency will be finalised by the Small Industries Development Corporation in consultation with the Director of Industries and Commerce. The Chairman & Managing Director, Small Industries Development Corporation is requested to take special steps to finalise the draft terms and conditions and submit them to the Government within 15 days.

iii) The date of vesting of the ownership of the Developed Plot Estates with the Government will be from 1.6.74, the date on which they were ordered to be transferred from the Director of Industries and Commerce to the State Industries Promotion Corporation of Tamil Nadu Ltd.

iii) The State Industries Promotion Corporation of Tamil Nadu will be treated as an agent of the Government in respect of Developed Plot Estates for the period from 1.6.74 till the date of issue of these orders. The terms and conditions of the agency in regard to State Industries promotion Corporation of Tamil Nadu for the above period will be the same as those to be made applicable in the case of Small Industries Development Corporation for being the agent of the Government for maintaining the Developed Plot Estates.

4. The Government also direct that the two functional Industrial Estates viz. the functional Industrial Estate of Leather goods at Nadhavaram and the Functional Industrial Estates for Food and Fruit based Industries at lagundu, be transferred from the Director of Industries and Commerce to the Small Industries Development Corporation on the lines on which conventional Industrial estates were transferred to the Small Industries Development Corporation.
